 Q: Does the Navajo Nation frequently participate in the Tribal Exchange Network? I'm curious because your headquarters is in Flagstaff, and I have had some academic connection to the environmental research on the Navajo Reservation.

- A: The Navajo Nation has not been a recent recipient of the Tribal Exchange Network's Grant Program. However, the Navajo Nation has had representatives at some of the meetings and conferences hosted by the TXG.
- Q: Any anticipation on when you might have a decision on the latest Tribal Exchange Network grant applications?
 - A: Our selection decision is being reviewed by management. Decisions should be available in the next two weeks.
