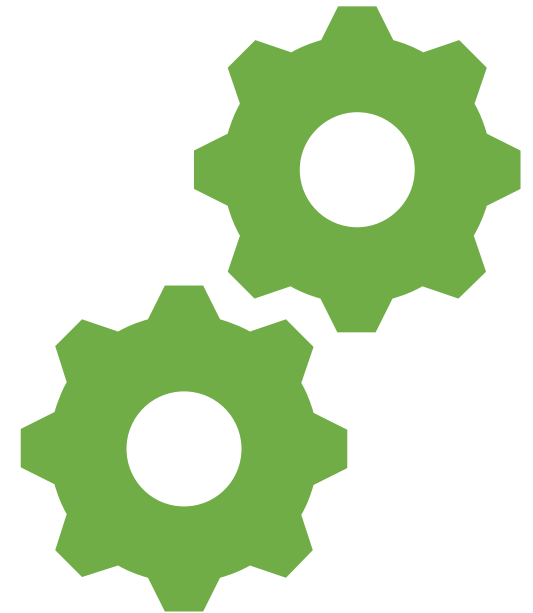
Format

- **We will send polls, surveys to gauge interests.** This is a call run by Exchange Network partners for Exchange Network partners.



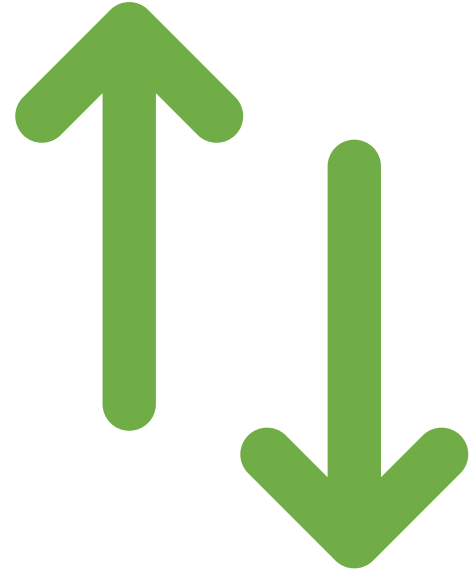

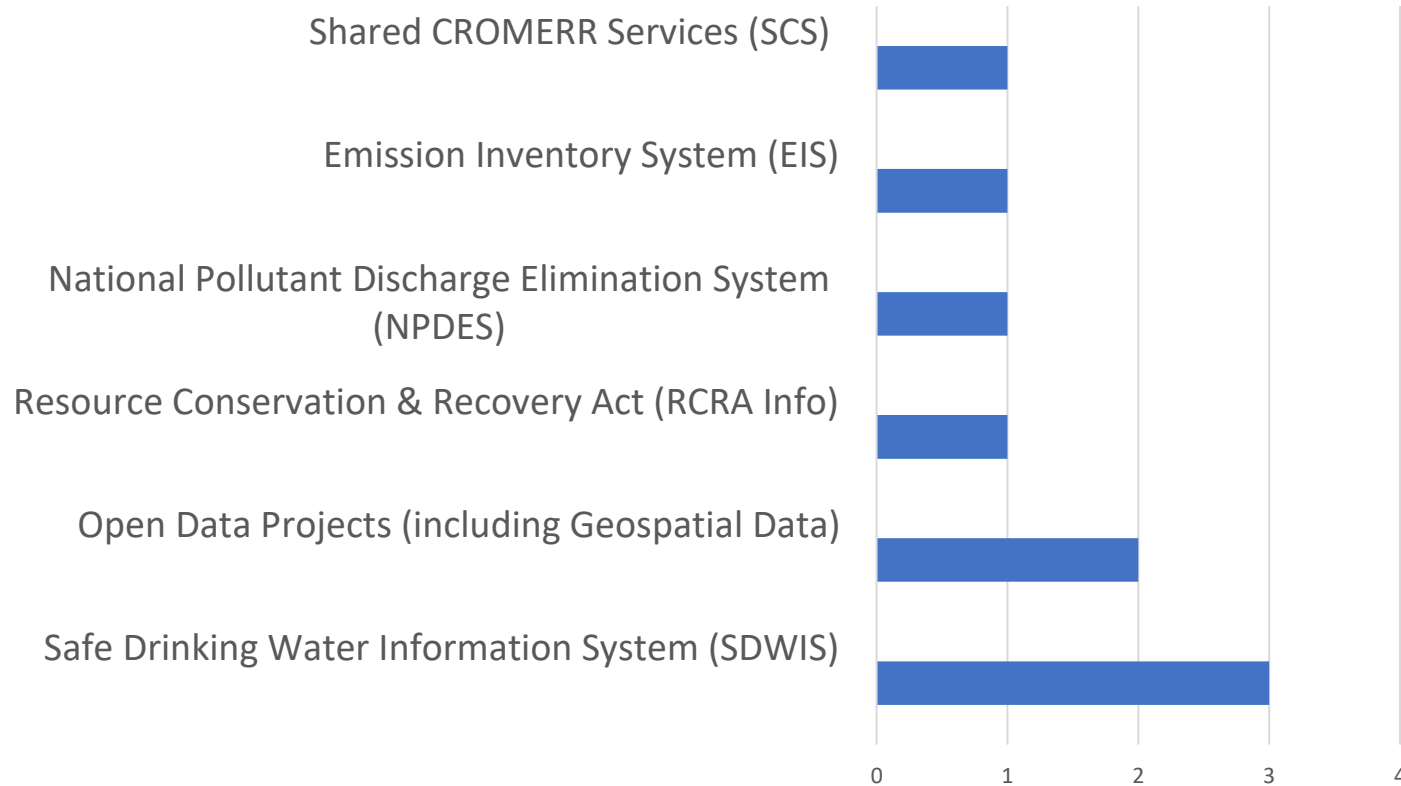

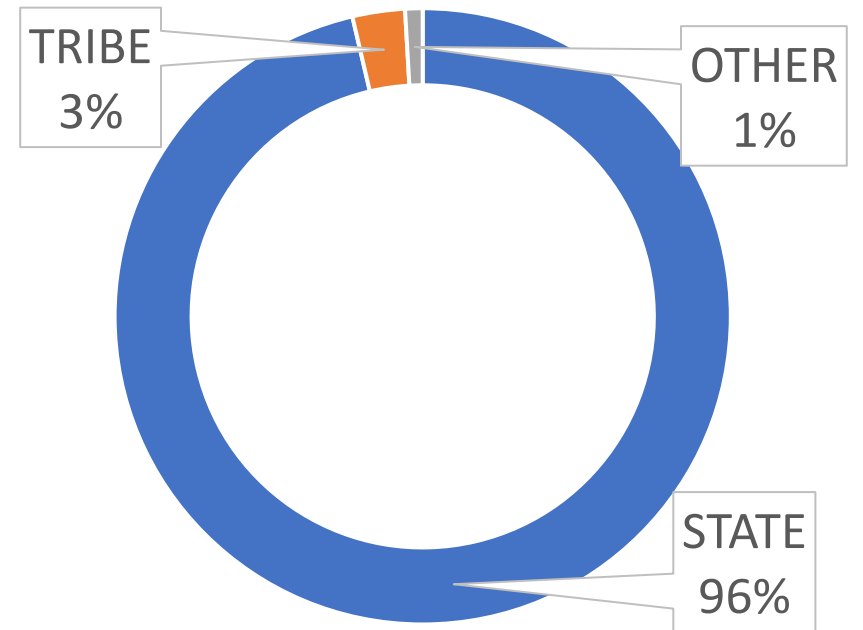
